PROPOSED ZONING DESIGNATION TO R-2
“RESIDENTIAL ZONING DISTRICT”

The City of Belle Glade, Florida, will conduct a Public Hearing and First Reading of an Ordinance on Monday, August 21, 2017, at 6:30 p.m., or continuing from time to time and place to place as said meeting may be adjourned to hear the public, in City Hall Commission Chambers, located at 110 Dr. Martin Luther King, Jr. Blvd., West, Belle Glade, Florida, 33430, to consider the First Reading of proposed Ordinance, which title reads as follows:

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, REZONING A .43 ACRE PARCEL OF VACANT REAL PROPERTY LOCATED ON LINDA ROAD, AS MORE PARTICULARLY DESCRIBED HEREIN, FROM THE R-1 “RESIDENTIAL ZONING DISTRICT” TO THE R-2 “RESIDENTIAL ZONING DISTRICT” AND MAKING CERTAIN FINDINGS OF FACT; DETERMINING CONFORMITY WITH THE COMPREHENSIVE PLAN; AMENDING THE OFFICIAL ZONING MAP; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
