

PUBLIC NOTICE
AMENDING CHAPTER 31 “ZONING”
PROPOSING TO ALLOW EDUCATIONAL AND TRAINING
CAMPUSES AND FACILITIES SUBJECT TO ADDITIONAL
CONDITIONS

The City of Belle Glade, Florida, will conduct a Public Hearing and First Reading of an Ordinance on Monday, December 18, 2017, at 6:30 p.m., or continuing from time to time and place to place as said meeting may be adjourned to hear the public, in City Hall Commission Chambers, located at 110 Dr. Martin Luther King, Jr. Blvd., West, Belle Glade, Florida, 33430, to consider the First Reading of proposed Ordinance, which title reads as follows:

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING CHAPTER 31 “ZONING”, ARTICLE II “DISTRICT REGULATIONS”, DIVISION 11, “I-2 GENERAL INDUSTRIAL DISTRICTS,” OF THE CITY CODE OF ORDINANCES BY AMENDING SECTION 31-227, “PERMITTED PRINCIPAL USES,” TO ALLOW EDUCATIONAL AND TRAINING CAMPUSES AND FACILITIES SUBJECT TO ADDITIONAL CONDITIONS; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

All members of the public are invited to appear at the public hearing, which may be continued from time to time, and be heard with respect to this matter. Copies of all related documents are available for inspection and copying in the Office of the City Clerk during regular business hours, Monday through Thursday from 7:30 a.m. – 6:30 p.m.

Should any interested party seeking to appeal any decision made by the City Commission with respect to any matter considered at such meetings or hearings, such person will need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. (Reference: Florida Statutes 286.0105)
