

NOTICE OF PUBLIC HEARING

The City Commission of the City of Belle Glade shall conduct a Special Public Hearing on Tuesday, May 16, 2017 at 5:00 p.m. or as soon thereafter as this matter may be heard, in the Commission Chambers of City Hall, located at 110 Dr. Martin Luther King, Jr. Blvd, West, Belle Glade, Florida, 33430. The City Commission shall consider adoption by Resolution the following matter pursuant to the City of Belle Glade Code of Ordinances Section 31-364:
