The Belle Glade City Commission will consider adoption of proposed municipal Ordinances, title of which are as follows:

### ORDINANCE NO. 17-06

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING CHAPTER 19 "PEDDLERS, SOLICITORS, AND ITINERANT VENDORS", ARTICLE II "PEDDLERS, SOLICITORS, TRANSIENT VENDORS AND MOBILE VENDORS – FOR PROFIT", DIVISION 1 "GENERALLY", SECTION 19-11 "DEFINITIONS", DIVISION 2 "PERMIT; LOCAL BUSINESS TAX RECEIPT; LICENSURE", SECTION 19-21 "GENERAL REQUIREMENTS", DIVISION 3 "RESTRICTIONS", SECTION 19-41 "GENERAL RESTRICTIONS" AND SECTION 19-42 "ADDITIONAL RESTRICTIONS APPLICABLE TO MOBILE VENDORS ONLY" TO RESTRICT THE PEDDLING OF GOODS FROM STATIONARY LOCATIONS AND TO PROVIDE EXEMPTIONS FOR MOBILE FOOD VENDORS; AMENDING DIVISION 4 "ENFORCEMENT; PENALTIES; REVOCATION" TO PROVIDE FOR THE REVIEW OF PERMIT DENIALS AND REVOCATIONS BY THE SPECIAL MAGISTRATE AND FOR OTHER PURPOSES; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AUTHORITY TO CODIFY AND AN EFFECTIVE DATE.

### ORDINANCE NO. 17-07

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING THE CODE OF ORDINANCES, CHAPTER 2 "ADMINISTRATION", ARTICLE VIII "FINANCE", DIVISION 3 "PURCHASING", SECTION 2-431 "PURCHASING CODE" AT SUBSECTIONS 2-431 (B), 2-431(C), AND 2-431(D) TO AMEND THE SPENDING AUTHORITY OF CITY STAFF AND THE MONETARY THRESHOLDS REQUIRING QUOTES AND OTHER REQUIREMENTS, TO PROVIDE THE CITY COMMISSION THE AUTHORITY TO WAIVE PURCHASING REQUIREMENTS UNDER CERTAIN CIRCUMSTANCES AND FOR OTHER PURPOSES; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AUTHORITY TO CODIFY, AND AN EFFECTIVE DATE.

Said Ordinances will be considered for second and final reading during the Regular meeting of the City Commission to be held on the 21<sup>st</sup> day of August, 2017 at 6:30 p.m., or continuing from time to time and place to place as said meeting may be adjourned to hear the public, at City Hall, 110 Dr. Martin Luther King Jr., Blvd., West, Belle Glade, Palm Beach County, Florida. Copy of said proposed ordinances are available for inspection in the office of the City Clerk located at the aforementioned address.

Should any interested party seek to appeal any decision made by the City Commission with respect to any matter considered at such meetings or hearings, such person will need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
