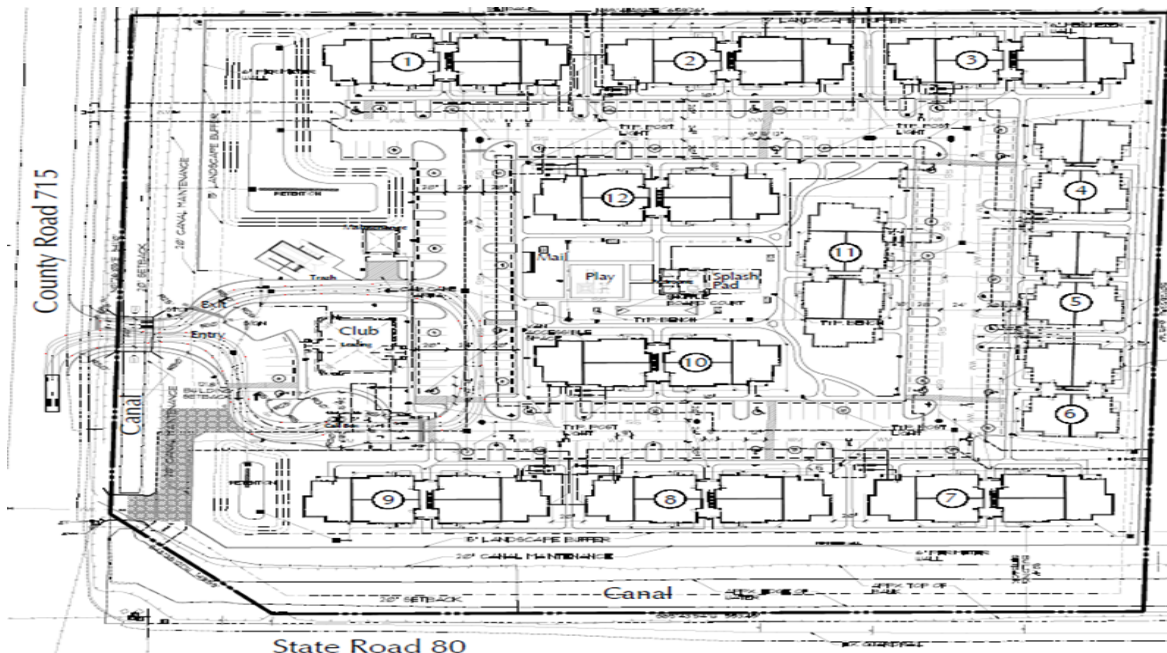
RESOLUTION DESIGNATING BROWNFIELD AREA

The City Commission of the City of Belle Glade shall conduct a Public Hearing on Monday, February 26, 2018 at 5:30 p.m. or as soon thereafter as this matter may be heard, in the Commission Chambers of City Hall, located at 110 Dr. Martin Luther King, Jr. Blvd, West, Belle Glade, Florida, 33430. The City Commission shall consider adoption by Resolution on the following matter pursuant to the City of Belle Glade Code of Ordinances Section 31-364:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, DESIGNATING PROPERTY LOCATED AT THE NORTHEAST CORNER OF THE INTERSECTION OF STATE ROAD 80 AND STATE ROAD 715, BELLE GLADE, FLORIDA 33430, AND IDENTIFIED BY PROPERTY CONTROL NUMBER 04-37-44-06-00-000-7020, AS A BROWNFIELD AREA PURSUANT TO SECTION 376.80(2)(C), FLORIDA STATUTES, FOR THE PURPOSE OF REHABILITATION AND PROMOTING ECONOMIC REDEVELOPMENT; AUTHORIZING THE CITY OF BELLE GLADE TO NOTIFY THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION OF SAID DESIGNATION; AND PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
