AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING THE RETIREMENT PLAN FOR FULL-TIME EMPLOYEES; AMENDING THE REQUIRED MINIMUM DISTRIBUTION AGE PURSUANT TO COMPLY WITH THE INTERNAL REVENUE CODE; AUTHORIZING THE BOARD OF TRUSTEES TO CREATE AND AMEND AS NECESSARY AN INTERNAL REVENUE CODE QUALIFICATION POLICY; PROVIDING FOR CONFLICTING ORDINANCES AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, ADOPTING THE ANNUAL UPDATE TO THE FIVE-YEAR CAPITAL IMPROVEMENTS SCHEDULE IN ACCORDANCE WITH SECTION 163.3177(3), FLORIDA STATUTES; PROVIDING FOR THE REPEAL OF ORDINANCES OR RESOLUTIONS IN CONFLICT, SEVERABILITY, AND AN EFFECTIVE DATE.

ORDINANCE No. 2022-11

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING CHAPTER 2 "ADMINISTRATION", ARTICLE I "IN GENERAL", SECTION 2.1 "LEGAL HOLIDAYS; CLOSING OF CITY HALL," BY AUTHORIZING ONE ADDITIONAL DAY AS A LEGAL HOLIDAY AND DESIGNATING THAT DAY AS JUNETEENTH, JUNE 19 OF EACH CALENDAR YEAR AND BY PROVIDING THAT CITY HALL IS CLOSED ON FRIDAYS; AND PROVIDING FOR CONFLICTS, SEVERABILITY, CODIFICATION AND AN EFFECTIVE DATE.

Said Ordinances will be considered for second and final reading during a regular meeting of the City Commission to be held on Monday, December 19, 2022, at 6:30 p.m., or continuing from time to time and place to place as said meeting may be adjourned to hear the public, at City Hall, 110 Dr. Martin Luther King Jr., Blvd., West, Belle Glade, Palm Beach County, Florida. Copies of said proposed ordinances are available for inspection in the office of the City Clerk located at the aforementioned address.

Should any interested party seek to appeal any decision made by the City Commission with respect to any matter considered at such meetings or hearings, such person will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
